After the Department of National Revenue reported in 1967 that they had no longer a requirement for the building, several unsuccessful attempts were made to find alternate federal uses for it. Disposal action was begun in May 1969, but was delayed due to technical difficulties in obtaining survey documents. Actual disposal action is now well advanced and the necessary documents are being transmitted to the Crown Assets Disposal Corporation.
