## LETTER SENT BY M. DAN BARTHOLOMEW, C.P.S.

## Question No. 2,494-Mr. Reynolds:

Was a letter, regarding inmate No. 1,357 McCauley, dated June 10, 1973, sent by Mr. Dan Bartholomew Cx4 to the British Columbia Penitentiary prison director, answered and, if not, for what reason?

Hon. Warren Allmand (Solicitor General): No. Mr. Bartholomew's letter was referred to the senior institutional officer concerned for his consideration and advice. Action was taken on the matter raised by Mr. Bartholomew the following day. However, due to a conflict in shift schedules between Mr. Bartholomew and his squad leader, Mr. Bartholomew was not immediately informed of the action taken. He was, nevertheless, informed at the earliest possible opportunity.

# CANADIAN PENITENTIARY SERVICES—MR. BRIAN MURPHY AND MR. G. W. H. L. SCHLIEPER

### Question No. 2,495—Mr. Reynolds:

- 1. Will the Solicitor General advise whether (a) charges are pending against Mr. Brian Murphy (b) he is allowed to come and go from prison and, if so, for what reason?
- 2. (a) Are charges pending against Mr. G. W. H. L. Schlieper (b) is he permitted to continue at his job or in some other form of work and, if not, for what reason?
- Hon. Warren Allmand (Solicitor General): 1. (a) Yes. (b) Yes. Mr. Murphy is employed as a research officer studying inmate profiles and, therefore, his work, unlike that of correctional officers, does not require him to be in daily contact with inmates in a supervisory, teaching or counselling relationship. His continued employment, pending the disposition of charges now before the Court, did not and does not in any way jeopardize the security of the institution. Since charges were laid, Mr. Murphy has visited the institution once to meet with the Assistant Director, Socialization.
- 2. (a) Yes. (b) No. Mr. Schlieper is a correctional officer, and is therefore, in daily contact with inmates. It is considered that his entry to the institution could pose a risk which may affect the security of the institution and the safety of both staff and inmates. Accordingly, he has been suspended pending the disposition of charges against him.
