I think we have perhaps managed to establish that there are some norms in parliamentary language which all members would want to observe in co-operation with the Chair, because I am here not to invent rules but to put into force rules which members have agreed to and expect the Chair to put into force.

**Mr. Speaker:** Is it the pleasure of the House to adopt the motion proposed by the hon. member for Peace River?

## STATUS OF WOMEN

## ANNOUNCEMENT OF ESTABLISHMENT OF ADVISORY COUNCIL, TERMS OF REFERENCE AND NAMES OF MEMBERS

**Hon. John C. Munro (Minister of Labour):** Mr. Speaker, I should like to make a statement on motions and table documents in both official languages under Standing Order 41(2) concerning this government's action with regard to the status of women.

As you know, I recently announced my intention to establish an advisory council on the status of women. I would like now to announce the terms of reference for this council, and the names of the members to be appointed to it.

The purpose of the council will be twofold: to bring before the government and the public matters of interest and concern to women, and to advise the government on actions that it deems necessary to improve the position of women in society.

The terms of reference for the council are as follows: to advise the minister responsible in respect of such matters relating to the status of women as the minister may refer to the council for its consideration, or the council considers appropriate.
