#### ANTI-INFLATION BOARD—METHOD OF MONITORING PRICE INCREASES

**Mr.** David Orlikow (Winnipeg North): Mr. Speaker, I should like to direct a question to the Minister of Finance. It arises out of a statement made yesterday by the chairman of the Anti-Inflation Board that the board will ask 100 of the largest firms to identify their main product lines as a basis for an efficient system of price monitoring. In view of the minister's admission yesterday that the government had difficulties with drafting a list of corporations to be covered by the guidelines, can the minister tell us how the board will handle the complexities of price monitoring?

Hon. Donald S. Macdonald (Minister of Finance): Mr. Speaker, this seems to me like one of the questions that might appropriately be asked in the committee and I will be glad to deal with it there.

**Mr. Orlikow:** In view of the intention of the Anti-Inflation Board, as announced by its chairman, to change the regulations governing the program as often as necessary to ensure that they are equitable and workable in their daily application, can the minister explain to the House how an effective system of price monitoring and control can be carried out in such a climate of change, or does the minister agree with the Minister of Industry, Trade and Commerce that virtually all excess profits will be exempt from the guidelines, thus making price monitoring unnecessary?

**Mr. Speaker:** Order, please. Similarly this question should be put to the minister in the standing committee. [Mr. Gillespie.]
