Solidarity, workers, intellectuals and dissidents be released right away. The petitioners hope, Madam Speaker, that in your examination of their petition you will find it in order, sense its urgency and allow its reading in the House.

Specific accountabilities: Implements a concept of a headquarters operations away from the national capital, with particular emphasis in the required interface with Parliament, the government, and other agencies and departments in the National Capital Region.

Order Paper Questions

Ensures the effective co-ordination (in terms of time costs and minimal disruption to clients) of all phases of the project with all functional areas and all operational changes involved.

Ensures the maintenance of the portfolio's management information base during relocation period by the documentation of all systems and procedures in the portfolio.

Ensures development of accommodation and facilities specifications and maintains a continuous working relationship with Public Works project officers during design, development and construction of the new building.
