(b) The deficit at Mirabel International Airport since it opened in November 1975 was \$192.6 million. This represents all aspects of the excess operating and maintenance expenses, including interest and depreciation, over revenues. The deficit before providing for interest and depreciation for the period was \$10.2 million.
