Hon. W. S. FIELDING (Minister of Finance). The matter will receive the consideration of the government in connection with the coming estimates.

Mr. R. L. BORDEN. When may I expect the return for which I moved in connection with the cost to date and the estimated future cost of the eastern division of the National Transcontinental Railway?

Hon. G. P. GRAHAM (Minister of Railways and Canals). I asked my department to rush that return and also directed them to comply with the request of my hon. friend to include in the return anything that was embraced in the question which he withdrew.

Mr. PORTER. When may I expect the return ordered on January 15, with reference to royal commissions appointed by the government since 1896?

Mr. CROCKET. When may I expect a return moved for on December 18 for a statement showing the post office services in the different counties of Nova Scotia and New Brunswick?

Hon. RODOLPHE LEMIEUX (Postmaster General). I have the returns for several counties ready and expect that the remainder will be ready in a few days. Probably next week I shall be able to lay the papers on the table of the House.
