of such quality that it could not be expected to receive the commendation of the large body of the electors.

Mr. MacDonald said that he stood as a candidate for alderman on the People's party ticket and if the people of Dawson chose to repose their confidence in him he would endeavor to do something more practical than platform speaking.

Dr. Thompson followed and as upon the decision of the meeting Monday evening was in good voice and showed evidence of careful grooming. He extolled the virtues of the Kid committee, which he said was a model of consistency and logical conclusions.

His ticket was the most representative of any in the field and the People's party he characterized as a platformless party. The speaker emphatically repudiated the use of his name on the Consomme ticket arranged by the News and denied with much force the rumor that there were dissensions in the ranks of the Kids.

The chairman next called upon Chas. Macdonald, but upon that gentleman protesting that it was not his turn to speak, Mr. Macaulay came quickly forward and generously offered to take his place. He said:

"It is a source of great gratification to me tonight to see so many ladies in our midst, and to see some who have votes here, and after all, ladies, it is votes that we are after, and that is what brings us here tonight. (Laughter.) Now, you all know I am not a public speaker, having only appeared on the platform once before, but I would like to make reference to our platform, and as regards to one who is interested in the liquor business, wish to state that the position I have been placed in I have never asked for. I therefore feel that I will look after the interests of Dawson, and will always do so, if elected.

"The eleventh plank of the platform says that we will request the government at Ottawa that saloonkeepers of Dawson have the same privileges commercially as are accorded other lines of business. Now, I am in the liquor business, and I feel safe in saying that if the Dominion government takes away the right of issuing permits to any certain clique or class of people, I can then live without the liquor business. We have always carried a large class of other goods into this country beside liquor, and up to the present time this year we have made no money out of the liquor business. There are many things that are unknown in this business, and my friends need not laugh. We have not taken a dollar out of this country but have invested it here in your midst in buildings. I have got my home here, and expect to have it here for years to come. (Hear.)

"Now, some gentlemen have referred to our not having any wage earners on our ticket. I am sure that so far as we are concerned we are all working for the labor element. What is to the interest of the merchant is to the interest of the laboring man; and as far as that goes I myself have had a little to do in the laboring line, if you will excuse my being egotistical. But when a man's picture appears in the evening paper, showing his history and qualifications, I deem it my duty to say something in regard to myself. I started away from Lindsay, Ontario, when sixteen years of age, and from there went into the shanties and handled an axe and saw with the best of them, and came down the river in the spring of the year on rafts, and remained in the lumber industry where one can get all the practical education he desires. It is not a pleasant thing for one to talk about himself, but so far as wage earners are concerned, that is the man you want when you are looking for a man for mayor, and I think, as you are after practical men, I may say that I have those qualifications, as well as being successful in business. I was successful on the outside, too. It is pretty hard to talk, boys, but I think it is not always men who can talk who are successful in business.

"If elected, I assure you, gentlemen, I shall do all in my power to keep a keen eye on events and things, and my watchword shall be that there must be economy and efficiency in everything. After all, the workings of municipal affairs are nothing but the same as the workings of any business house. You always have to exercise the best judgment in the council as in business. We hope our friends will support us as far as they are able to. I shall certainly do the best I can for the interests of the country. Some say we are after 'graft,' and I say that if elected I will go into the chair without accepting a dollar in consideration for anything." (Prolonged applause.)

Charles Macdonald, of the silver tongue, followed Mr. Macaulay, stating by way of a preface to his remarks that he was happy to receive the same glad hand that had been extended so freely to his opponent at the meeting Monday evening. He ventured the opinion that of the votes held by the ladies present Dr. Thompson was not entitled to one of them as a penalty for having gone through life so far in a state of single blessedness. (Laughter and applause.) The speaker again referred to the acts of the Solid Ten in the convention when amalgamation of that which is now the Citizens' and People's party was being attempted, but failed to bring out clearly the essential features. He neglected to state that after the first three informal ballots had been held that his supporters refused to go into session and take a decisive ballot because he was in the minority. He also neglected to make mention of the fact that the representatives of the Taxpayers' committee had given their opponents the choice of the entire city from which to select the candidate for mayor, saving the exception of himself, pledging their unanimous support to whoever might be chosen. He did not tell of the unceremonious bouncing of everyone from the general meeting, including members of the press, who would not sign the roll and the subsequent railroading through of his own nomination. When speaking of the Solid Ten who had stood for him like a wall of granite, he had elucidated a few more facts concerning the actions of the bolters, the real and only cause of the present split in the ranks of the more responsible element of the city who would save Dawson from the clutches of the Kid committee, it would have been far more gratifying, though perhaps suicidal to his own ambitions. The speaker made a futile effort to create capital out of the "whisky trust" by making some comparisons between outside and Dawson prices, but he overlooked the opportunity to tell his hearers that whisky today is cheaper than was ever before known in the history of the Yukon.

AGAIN IN TROUBLE

Chas. J. Anderson Sued in 'Frisco for Breach of Promise.

Alma de Bretteville yesterday brought a breach of promise suit against Charles J. Anderson, demanding damages in the sum of \$50,000. The action is the culmination of the troubles between the two, of which an account was given in last Monday's issue of "The Examiner." Anderson is a returned Klondiker, understood to be possessed of much wealth—a former wife, who once figured as a vaudeville performer under the name of Maude Drummond, is credited with having secured a considerable portion of what he once had during their short and troubled domestic experience, which a divorce finally ended. After the separation, Anderson went back to the Arctic, whence in due time he returned, again in funds, and promptly fell in love with Miss Alma de Bretteville.

The latter is a gifted art student, as well as a particularly prepossessing young lady, and lives with her parents at 1024 Francisco street, her father and brother being ship-building machinists employed at the Fulton Iron Works.

In her complaint the plaintiff sets forth that Anderson asked her, on November 5th last, to marry him, and that she consented, but that he has since failed to keep faith with her. Therefore she demands \$50,000 as already stated.

The complaint is very brief, and gives no details whatever, but it is known that what particularly exasperated Miss de Bretteville and her family was the fact, as had been represented to them, that the Klondiker had a habit of making free with the young lady's name among his boon companions.—Examiner, Jan. 5.

THISTLE CREEK

Is Making Wonderful Showing This Winter.

Thistle creek is making an excellent showing this winter and is reported as being the coming pay creek of this country. Several stampedes to this district have recently occurred and the creek from source to flow is practically covered by stakes.

Mr. Frank C. Williams, who is interested in Thistle property, returned last evening from an investigating trip to the district and gave to the Nugget a report of the work being done on the creek.

Claims Nos. 15, 17, 18, 19, 32, 39, 53, and 91, below discovery, are being prospected, and on each the pay streak has been located. Above discovery 15 and 19 are known to be working, but whether there are more than these two Mr. Williams was not sure, as he did not go above discovery.

The pay streak in nearly all the claims has been found on the extreme left limit under the ledge of the hill. The gold is coarse and is found from 6 to 12 inches in the gravel above bed rock.

On the two claims above discovery, 15 and 19, an average of 11c to the pan is estimated, but the pay below discovery runs considerably higher than this. Two buckets holding four pans each of dirt from 17 when rocked out yielded the nice little sum of \$12.80, which would make an average of about \$1.60 to the pan. The lowest returns from any bucket which has been tested is 60c, and from that runs up into large amounts. On 19 a steam thawer is being used to aid in the working of the claim and another plant is to be set up on 17 within a few days.

Other claims next summer will be worked with complete steam plants and the creek will be the scene of great activity. Mr. Williams reports a stampede to Scroggy creek, a tributary entering the Stewart river about 30 miles from mouth and having its source near the head of Thistle. About 30 claims have been staked and the discoverer claims to have found \$1.50 to the pan.

Ballaat is another creek in the Stewart district which shows signs of becoming a producer of the precious metal. This creek is a tributary of the Yukon and has its source in the same divide as Thistle and Scroggy. Mr. Johnson, who is the proprietor of the road house at Stewart, received a letter recently from his son who is at work on Ballaat, in which it is stated that in going down 4 feet into gravel \$10 had been panned out and that bed rock was not then in sight. This is an excellent showing and gives good promise for future developments.
