MEASURES TO REDUCE COST OF SINGLE FAMILY HOMES— REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

ALLEGED RACIAL DISCRIMINATION—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

Mr. Elmer M. MacKay (Central Nova): Mr. Speaker, I rise under the provisions of Standing Order 43 to seek the unanimous consent of the House to move a motion of urgent and pressing necessity. This motion is pursuant to the participation by students in the Young Voyageurs Program to which the Department of the Secretary of State contributes and also to the report that a white girl from Cardston, Alberta, apparently may have been advised or directed not to stay at the home of a black girl at New Glasgow, Nova Scotia, thus apparently contradicting the aims of programs such as these funded by all Canadians and designed to encourage personal interaction among Canadians from different regions of the country. Therefore I move, seconded by the hon. member for Hamilton West (Mr. Alexander):

That the Secretary of State take whatever action he considers appropriate to ensure that as an integral part of all programs to which his department contributes in any way there are guidelines or conditions that there be no discrimination involved, thus setting out the principles implicit in the Canadian Bill of Rights.
