## HARBOUR FACILITIES, 16-MILE CREEK, OAKVILLE, ONTARIO

## Question No. 291-Mr. O'Connor:

Is the government considering undertaking a detailed investigation into the adequacy of the harbour facilities at the mouth of 16-Mile Creek in Oakville, Ontario and, if so, is it considering initiating redevelopment of such facilities in co-operation with the Town of Oakville and the Province of Ontario?

**Hon. Jean-Eudes Dubé (Minister of Public Works):** No. The harbour of Oakville is not a federal facility. It is owned, controlled and administered by the Corporation of the Town of Oakville.

1. By what program and under what authority were the departmental logos changed from the Coat of Arms of Canada to the present logos?

**Hon. Warren Allmand (Solicitor General):** Mr. Speaker, the answer to parts 1 and 2 is as follows: the primary responsibility for determining where Royal Canadian Mounted Police detachments shall be located within those provinces policed by the force on a contract basis rests with the Attorney General of the respective province. However, I have been informed that there are no current plans to relocate the detachment now situated at Thorsby, Alberta.
