## POSSIBILITY OF URANIUM STOCKPILING PROGRAM IN LIGHT OF OVER-ALL SHORTAGE

Mr. J. R. Ellis (Hastings): Mr. Speaker, my question is directed to the Minister of Energy, Mines and Resources. In view of the over-all energy shortage, has the minister considered the possibility of a uranium stockpiling program? I am particularly interested, of course, in that part of north Hastings where there are four uranium mines sitting idle.

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, we have not specifically considered new stockpiling. We anticipate that with an improvement in the international price for uranium there will be a greater incentive to some of our existing Canadian mines to bring capacity back into production again. I would expect a bright future for the north part of Hastings County in particular.

## WHEAT—REASON FOR DELAY IN PAYMENTS TO ONTARIO PRODUCERS UNDER TWO-PRICE SYSTEM

Mr. R. E. McKinley (Huron): Mr. Speaker, I have a question for the Minister of Agriculture regarding payments to Ontario wheat producers under the two-price system. A few weeks ago we were informed by the grains division of his department that a formula would be worked out and payments made before too long. I understand that the formula has not been worked out and nothing has been done. What is the reason for the delay and when will things be straightened out?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, the \$8.3 million are to be paid out to Ontario wheat producers under an agreement we have with the Ontario Winter Wheat Marketing Board. As soon as we receive information from that board, these payments will be made. We are awaiting that information at the present time.

#### INTENTION RESPECTING LEGISLATION TO MERGE REGULATORY FUNCTIONS OF RADIO-TELEVISION AND TRANSPORT COMMISSIONS

Hon. Gérard Pelletier (Minister of Communications): Yes, Mr. Speaker. However, we have taken no final decision on this because of the legislative requirements of the government program.

**Mr. Nowlan:** Mr. Speaker, in view of the desire stated by the minister at the conference to negotiate, discuss and consult with the provinces, will the federal-provincial officials committee that is supposed to meet early next year have any legislative input?

#### [Translation]

**Mr. Pelletier (Hochelaga):** Mr. Speaker, with regard to the legislation as a whole, we promised the provinces we would discuss it anew with them before introducing it. But I warned at the federal-provincial conference, and the hon. member must be acquainted with my statement, that concerning the first part which deals primarily with the federal government's straightening out its own affairs, that we would consider ourselves free to legislate without any further consultation with the provinces, especially because the latter seem in no rush to hold another conference.
