AGRICULTURE

EGGS—RECONCILIATION OF IMPORTS WITH DIRECTIONS TO REDUCE CANADIAN PRODUCTION

Mr. Gordon Towers (Red Deer): Can the Minister of Agriculture explain to the House how he reconciles the importing of eggs into Canada, as was done prior to Christmas and again in recent weeks, with directions to Canadian producers to cut back production?

Hon. E. F. Whelan (Minister of Agriculture): I am sure the hon. member knows that it has been customary to import eggs into Canada from time to time. A surprising factor has been the increase in Canadian consumption. The other day I used the figure of 9 per cent as representing the increase over and above any other months of January or February. I was wrong. The increase in consumption amounted to 14 per cent.

Mr. Towers: Can the minister tell the House whether or not it is cheaper to import eggs than to produce them in Canada?

Mr. Whelan: It is rather costly. CEMA had to pay the extra cost because the United States eggs coming in at that time were more expensive than were eggs in Canada.
