Right Hon. John N. Turner (Leader of the Opposition): Mr. Speaker, I can only say, at the beginning of a new year in Parliament, that we did not start this particular performance of applause, but I do want to say to the Prime Minister, in personal terms, that I wish him health and happiness. An Hon. Member: It is a sacred trust.

Mr. Epp (Provencher): Yes, a sacred trust, and that is what we maintain.

Some Hon. Members: Hear, hear!

Mr. Epp (Provencher): That being the case, the Right Hon. Leader of the Opposition, I am sure when he sees the paper next Monday, a week today, will have our positions confirmed, and not his alleged agenda.
