Riis (Kamloops): Madam Speaker, I have the honour to present a petition on behalf of a number of western Canadians who point out that two Canadians, Christine Lamont and David Spencer, have been sentenced to 28 years each in a Brazilian prison and there they have suffered miscarriages of justice, cruel

The petitioners point out that the cumulative effect of these irregularities provide ample ground for the Government of Canada to seek a remedy on their behalf and are calling upon Parliament to urge the Secretary of State for External Affairs to request the Government of Brazil to expel Christine Lamont and David Spencer and return them to Canada.

NATIONAL REFERENDUM

Mrs. Edna Anderson (Simcoe Centre): Madam Speaker, I am presenting this petition on behalf of my constituents of Simcoe Centre who have signed this petition: "The undersigned believe that constitutional amendments should be ratified by the people of Canada via a referendum".

VIOLENCE

Mr. Garth Turner (Halton—Peel): Madam Speaker, I have the honour to present to the House petitions signed by more than 1,500 of my constituents, petitions which were prompted by the murder in August 1991 of Nina de Villiers. These constituents feel that vulnerable persons in our society are currently not being protected adequately by our justice system. They feel that crimes of violence against people are intolerable and constitute the abhorrent crime that society faces. They are concerned that sentencing in crimes of violence does not appropriately reflect society's intolerance and abhorrence of these particular crimes.

They are petitioning this House to review the justice system so that there is more protection for vulnerable people in our society.
