Hon. T. D'Arcy Leonard moved, with leave of the Senate:

That the Standing Committee on Finance be authorized to examine and report upon the expenditures set out in Supplementary Estimates (C) laid before Parliament for the fiscal year ending 31st March, 1967; and

That the committee be empowered to send for persons, papers and records, to print its proceedings upon the said Supplementary Estimates (C) and to sit during sittings and adjournments of the Senate.

Motion agreed to.

## ADJOURNMENT

Hon. John J. Connolly: Honourable senators, I move, with leave of the Senate, that when the Senate adjourns this evening it do stand adjourned until Tuesday, November 29, at 8 o'clock in the evening.

This is the customary motion in the circumstances. It may well be that the Senate will be required for legislative work before November 29. If it becomes urgently necessary for the Senate to assemble before that date I will consult with His Honour the Speaker, and all honourable senators will be advised. It is expected that we will receive for consideration a bill respecting the National Housing Act, and a supply bill. There may be little other legislation for the present, but the month of December may be fairly busy, depending upon the speed at which legislation reaches us.

**Hon. Mr. Reid:** Does this mean we recess for two weeks?

Hon. Mr. Connolly (Ottawa West): It means that the Senate will not assemble again until Tuesday evening, November 29, unless it is recalled in the meantime.

Motion agreed to.

The Senate adjourned during pleasure.

## ROYAL ASSENT

The Honourable Robert Taschereau, P.C., Chief Justice of Canada, Deputy of His Excellency the Governor General, having come and being seated at the foot of the Throne, and the House of Commons having been summoned and being come with their Speaker, the Honourable the Deputy of His Excellency the Governor General was pleased to give Royal Assent to the following bills:

An Act respecting The Pacific Coast Fire Insurance Company.

An Act to provide assistance to livestock feeders in Eastern Canada and British Columbia.

The Honourable Lucien Lamoureux, Speaker of the House of Commons, then addressed the Honourable the Deputy of His Excellency the Governor General as follows:

May it please Your Honour:

The Commons of Canada have voted certain supplies required to enable the Government to defray the expenses of the public service.

In the name of the Commons, I present to Your Honour the following bill:

An Act for granting to Her Majesty certain sums of money for the public service for the financial year ending the 31st March, 1967.

To which bill I humbly request Your Honour's assent.

The Honourable the Deputy of His Excellency the Governor General was pleased to give the Royal Assent to the said bill.

The House of Commons withdrew.

The Honourable the Deputy of His Excellency the Governor General was pleased to retire.

The sitting of the Senate was resumed.

The Senate adjourned until Tuesday, November 29, at 8 p.m.
