Doctors Ask That the Care of the Patients Be Left to Them.

And That the Superintendent Be Released of All Medical Work-The Electrical Engineer's Appointment.

In response to an invitation from the board of trustees of Victoria Hospital, a committee from the Medical Association yesterday afternoon submitted to the board an exhaustive set of rules and regulations for the government of the hospital.

Certain sweeping changes were suggested as outlined in The Advertiser yesterday. The most important of these changes is the proposal to relieve the superintendent of all medical work, and the organization of the full medical the management of all matters relating to the treatment of patients, the chairman of this board to have a general supervision, while the work in the hospital will be under a resident medical officer and two assistants. The general superintendent, however, is to have full control of the hospital. Dr. Cl. T. They simply asked that the medical profession should control the treatment and care of the patients. That was the way all the large hospitals of which Dr. Campbell had any knowledge were conducted. The su-perintendent would be relieved of everything relating to the treatment of patients. His position would be purely executive. The doctors were willing to work without pay. The resident medical officer would be a young physician. who would be willing to accept the position for a year for his keep and the practice he would obtain. He would carry out the instructions of the med-

The proposed plan will be considered by a committee of the whole board of trustees next Wednesday. The medical men present were Dr. Cl. T. Campbell, Dr. Meek, Dr. George Wilson, Dr. Hodge and Dr. McLaren.

THE ELECTRICAL ENGINEER. In the matter of the appointment of an electrical engineer Mayor Wilson moved the resolution adopted by the city council, recommending the ap-pointment of S. H. Glass. In order to avoid any misunderstanding in future as to what board made the appointment, the motion was changed, making the appointment irrespective of the council's action. Mr. Gilmour sec-

onded. General Deloye Indulges in This Pastime,

And Finds Himself Vornered by Drey fus' Counsel-restimony Favors

Lennes, Sept. 2.-There was a large attendance and a number of generals at the Lycee this morning at the opening of the last session of the fourth week of the Dreyfus court-martial. The interest centered in the testimony of Major Hartmann, of the artillery, which was interrupted by the adjournment of the court yesterday and was resumed today. The major, who has done great service for the defense, resumed his important deposition regarding artillery matters and the bringing out of points and phraseology in the bordereau, indicating that the writer could not be Dreyfus.

THE ROBIN SHELL. The witness wished to go into the question of the Robin shell, but on Gen. Deloye objecting to a statement on the subject in open court, Major Hartmann asked to be allowed to make it behind closed doors, saying it would only take him a few minutes to call attention to the point he had in mind

The president of the court, Col. Jouaust, decided to hear this part of the witness's testimony, in camera, at the end of today's session or at the be-

ginning of Monday's session. In response to questions from Maitre Labori, leading counsel for the de-fense, and M. Demange, of counsel for the defense Major Hartmann said any officer attending the Chalons camp could have obtained sufficient information to write notes on the covering

of troops and Madagascar matters. M. Labori then recalled Gen. Mercier's attack on Capt. Freystaetter on the latter's declaration that the secret dossier communicated to the court in 1894, contained a document concerning a shell, for which Gen. Mercier called the captain a Fiar. Major Hartmann today affirmed that it was quite possible that particulars about a certain shell should have leaked out in 1894.

CALLED A "CONFRONTATION." An interesting confrontation between Gen. Deloye and Major Hartmann followed, the general declaring he did mot believe the major was keeping though it is suggested that since the strictly to the truth. Deloye then proceeded to point to what he said were imaccuracies in Major Hartman's testimony. He insisted that Dreyfus, in the course of conversations with artillery officers, could have secured inon on the subjects mentioned in the bordereau, to which the major retorted that if any military officer had been questioned by Dreyfus he would already have come forward to

say so, as a matter of strict duty.
Gen. Deloye, questioned by M. Labori and M. Demange, said the inventor of the Robin shell told him Dreyfus never asked him for particulars about his shell, except on minor points. The general added that he came as a technical witness to show Dreyfus could be guilty, adding that it was not his business to say that he believed him innocent or guilty. He could only say that Dreyfus' contention that it was impossible for him to know certain a natters referred to in the bordereau was untrue.

CORNERED BY M. LABORI. M. Labori asked Gen. Deloye if he knew whether the documents could have been betrayed by the traitor, expecially by the writer of the border eau, were important, whereupon the general turned to counsel and excitedly cried: "Don't ask me! Don't ask me!"

These exclamations created a sensation in court, which was doubled when Gem. Deloye added that there was sufficient in the bordereau to establish that the traitor knew the importance of the documents he was giving up. The witness said: "When I read the bordereau I was dismay-

Major Hartmann, in reply to Gen. Deloye, reiterated that the author of the bordereau was ignorant of artillery matters. "For," the major pointed out, "if he meant the '120' hydraulic brake he gave particulars of what was long known, while if he meant the '120' short, he employed a wrong expres-

MERCIER ONCE MORE. Gen. Mercier here mounted the stage and remarked that the writer of the
