THE ADVANCE ON TAMAL

A SUCCESSFUL ENGAGEMENT WITH THE ENEMY.

Many Arabs Killed and Only a Few British - Gallant Bearing of the Troops. SUAKIM, March 20.—The British again at 6 o'clock this morning in the same direction as yesterday. They carried two days' rations and 23,000 gallons of water. They

had six Gardiner guns. A Battle and its Results. London, March 20.—A special from Suakim states that a five hours' battle was fought in the vicinity of Hasheen this morning between the British troops and the forces of Osman the British troops and the forces of Osman Digna. Osman's position was finally captured. The Arab loss was very great.

On reaching the first hill at 8.30 it was found the enemy had retired and occupied another hill a mile and a quarter distant. After a short halt the Berkshire and marines cleared the hill, the Indian contingent and guards supporting. The enemy were driven off the ridge and were charged by the Indian lancers in the bush. The cavalry then retired toward the guards. Many of the enemy passed the gnards at the foot of the hill and made for a hill west of Hasheen. In the valley these were shelled by the Royal horse artillery, while other parties moving round our right were engaged in the bush by the Fifth lancers. A zareba, with four entrenched posts of the hill commanding it was found.

Two officers and two men of the British and five Sepovs were killed and twenty-six men of the British, one officer and ten men of the Indian contingent were wounded. The infantry behaved with great steadness. The number of the rebels is stimated at 4000. The rebel loss was heavy. The Arabs carried off all their dead and wounded. The Arabs maintained a steady rifle fire, retiring slowly from each position and avoiding close quarters.

LONDON, March 20.—Another account of the battle near Hasheen to-day says it was a hot the British cavalry charged repeatedly upon the Arabs, while the machine guns were by the Knights of Pythias of Toronto next year.

CAPTURE OF PENDJEH. The Federal Bank Bill Passes its Third

Reading in the Senate.

OTTAWA, March 20.—At the meeting of THE GOVERNMENT SAID TO BE the banking and commerce committee of WITHHOLDING INFORMATION. the senate this morning the Federal bank bill was reported without amendment. G. Lord Dufferin Said to Threaten Resigna-tion Unless he is Given More Power W. Yarker, the general manager, reviewed and explained his report of November last, For the Protection of the Frontier. upon which the bill was founded, dealing with his subject in a remarkably clear

and concise speech, ensuring the success of the bill. He stated that the local managers estimated the losses by some \$200,000 less than he, which, he said, if found correct, by and by would be very

if found correct, by and bye would be very gratifying, as the large amount written off by the bill of course did not prelude the collection of this or any other surplus asset. He explained the method adopted in finding the value of the bank and the solution he had proposed, viz.: The cancellation in full of the \$500,000 of the stock owned by the bank, so as to free its future business of a dangerous factor and give 50 per cent, to the remaining \$2,500,000 of shareholders. He said the means of the bank, after deducting the losses, for doing business were over \$4,000,000 and were slowly but steadily enlarging, the increase in deposits and circulation together for February alone being \$148,000. The New York and London credit and drawing arrangements were members are hard at work rushing through private bills concerning their own co stituencies. Yeste day's session was characterized by the detailed consideration of the following bills: To further amend the division courts act—Mr. Fraser. MUNICIPAL LAW AND COURT-

Provisions of the Consolidated Ontario Act-How it Effects the Present Dif-

ficulty.

The provisions of the municipal law relating to the erection and maintenance of courthouses by cities and towns united for judicial purposes will be found in the consolidated municipal act of 1883, sec. tions 346.7, 469-70-1-2. The effect of these clauses is that where the city and county are so united, the councils of the two may authorize the issue of debentures to any amount they may think necessary for the purpose of procuring a site, erecting for the purpose of procuring a site, erecting a courthouse and furnishing it without submitting a bylaw to the vote of the electors. But under agreement with the county, bearing date June 26, 1884, and contained in schedule A of the bill now before the legislature, the city is obliged to provide the site, erect the building and maintain it, the county council having to pay its proportion, based upon the coat of the investment—the investment not to exceed \$400,000—and the work to be completed within three years and six months from the date of the agreement.

The question at issue is, will the legiplature recognize the validity of this agreement, and allow the city council to alone avail itself of the provisions of the municipal act and issue debentures. The council will doubtless discuss the point Monday night, when it is expected that the legislative committee will prevent a report on the question. It having been decided to hold a labor demonstration in this city early in the ensuing summer, a committee of one from each body represented was appointed to carry out details.
