Department of Transport or the maritime commission any knowledge as to whether other countries, giving a similar subsidy, follow this same procedure?

## Answer by: Mr. Martini:

No. The applicable paragraphs of the regulations read as follows:

- 2. (i) "shipbuilders" means a Canadian citizen or a corporation incorporated under the laws of Canada, or any province of Canada that is engaged in the business of shipbuilding;
- (j) "shipowner" means a Canadian citizen, a corporation incorporated under the laws of Canada or of any province, or Her Majesty in right of any province.
