AIR SAFETY BILL

MEASURE RESPECTING LOCATION OF CRASHED AIRCRAFT, ASSISTANCE TO OCCUPANTS

Mr. Speaker: The hon. member for Okanagan Boundary. Is the hon. member for Burnaby-Richmond rising for the purpose of moving this bill on behalf of the hon. member for Okanagan Boundary?

Mr. Goode: That is correct, Mr. Speaker.

Mr. Speaker: The hon. member can do this only with the unanimous consent of the House. It is the practice that a private bill cannot be moved by another member in the absence of the mover of the bill unless there is unanimous agreement. The assumption is that the hon. member is doing this with the consent of the hon. member in whose name the bill stands on the Order Paper. Is this agreed?

Some hon. Members: Agreed.

Mr. Goode (for Mr. Howard, Okanagan Boundary) moved for leave to introduce Bill No. C-206, respecting air safety.

Some hon. Members: Explain.

Mr. Goode: Mr. Speaker, it is indeed a pleasure to explain the purpose of this bill for my colleague from Okanagan Boundary who this week is immersed at St. Johns, Quebec.

The purpose of this bill is to improve the method of search for and rescue of disabled aircraft. At present it costs the federal government over \$7 million each year for search and rescue operations. The bill is intended both to reduce costs and save lives.

Motion agreed to, bill read the first time and ordered to be printed.
