scenery. Some pictures included the Prime Minister. In two instances, the arrangements were initiated at the request of students; and others by Mr. O'Connell. In all cases, arrangements were concluded with the school authorities. Mr. O'Connell is paid on a monthly basis without deduction for time missed during conventional office hours nor with any additional compensation for evenings or weekends worked.

No study has been made of the potential off-shore mineral or other resources of these islands.

## CBC-TV STATION IN SEPT-ÎLES

## Question No. 579-Mr. Blouin:

With the completion of construction of the Telesat onshore stations in Sept-Îles and Fort Chimo, in the constituency of Manicouagan, on what date does CBC expect to have a television station in Sept-Îles with a French and an English network and is an extension of these networks planned east of Sept-Îles i.e. on the medium and lower North Coast?

Hon. James Hugh Faulkner (Secretary of State): I am informed by the CBC as follows: The French transmitter CBST Sept-Îles came into service on October 23, 1973, but the construction of studios is dependent on the eventual acquisition of a site in that town. The French TV network will be extended eastward towards Rivière-au-Tonnerre next September. Revised applications for VHF channels at Natashquan/Aguanish and La Romaine have been forwarded to CRTC, together with an application for Baie Johann Beetz. In addition, the municipality of Blanc Sablon is included in the Accelerated Coverage Plan and a rebroadcast transmitter will be established there later. As for the English network, the CBC intends to submit applications to the CRTC in 1976 for the establishment of stations at Sept-Îles, Harrington Harbour, La Tabatière/ Mutton Bay, St. Augustin/Saguenay, Old Fort Bay and Blanc Sablon.
