Mr. Lewis: Mr. Speaker, the Departments of the Environment, Fisheries and Oceans and the Ministry of State (Forestry) have informed us that the documents requested cannot be released pursuant to Section 20(1)(b) of the Access to Information Act. I therefore ask the Hon. Member to withdraw his motion.

Parliamentary Employment and Staff Relations Act

Mr. Fulton: Mr. Speaker, I have not had a chance to look at the precise nature of those documents listed in Motion No. 9 but I cannot imagine that they all fall under that Section of the Freedom of Information Act. I would ask that this motion as well be transferred for debate.

PARLIAMENTARY EMPLOYMENT AND STAFF RELATIONS ACT
