VIA RAIL

OPPOSITION TO TASK FORCE RECOMMENDATION ON FISCAL INDEMNIFICATION OF ISOLATED AND NORTHERN AREAS

Mr. Guy St-Julien (Abitibi): Madam Speaker, pursuant to Standing Order 36, I am today tabling a petition signed by workers in Lebel-sur-Quévillon and their wives against the task force on fiscal compensation for isolated and northern areas, which recommends abolishing travel deductions for medical reasons for northern workers within a year and limiting fiscal compensation for isolated and northern areas to places north of 51°05'N latitude.

Madam Speaker, the people of Lebel-sur-Quévillon reject the recommendations of the task force on fiscal compensation for isolated and northern areas because this task force did not take into consideration that in 1989, for the Government of Quebec, the North begins at the 49th parallel and that on May 26, 1989, the Minister of Finance changed the rules after consulting only 250 groups.

VIA RAIL
