REFERENDUM ACT

MEASURE TO ENACT

The House resumed from Tuesday, June 2, 1992 consideration of Bill C-81, an act to provide for referendums on the Constitution of Canada, as reported (with amendments) from a legislative committee.

Madam Deputy Speaker: It is very difficult for the Chair to hear what is going on on the floor. The hon. member for Churchill was seeking the floor on point of order.

Mr. Murphy: Madam Speaker, to assist members of the House, especially later on tonight, I would give notice that I will not move the motions standing in my name, Motions No. 14, 15, 17, 19, 23 and 47.

Madam Deputy Speaker: I thank the hon. member. The Table has taken notice and any member who would like to have those numbers written can come to the table.

Mr. Lapierre: Madam Speaker, on a point of order.

Mr. Lapierre: Madam Speaker, once the motions are before the House and the member decides not to move them himself, can another member do so on his behalf? Can he withdraw them without unanimous consent? I really would like to know.

Madam Deputy Speaker: A motion is before the House as soon as the Chair presents the motion to the House. If the hon. member decides not to move his motions, obviously the Chair will not present them. This means the motions bearing the numbers mentioned by the hon. member for Churchill will not be before the House.
