WATER DIVERSION

Mr. Brian L. Gardiner (Prince George-Bulkley Valley): Madam Speaker, I have the pleasure to table in the House today, under Standing Order 36, a petition signed primarily by the residents of Valemount, B.C. in my riding who are concerned about the whole question of water exports to the United States.

They have reason to be concerned because a water diversion project just south of that community is currently under consideration. These petitioners encourage and hope that the Canadian government will ensure that there will not be any large scale diversion of water to the United States.

WESTRAY MINE

Mr. Francis G. LeBlanc (Cape Breton Highlands – Canso): Madam Speaker, pursuant to Standing Order 36, it is my privilege and honour to present a large number of petitions calling upon Parliament to encourage the Governor General of Canada to recognize the bravery of the draegermen who sought to recover the bodies of the 26 miners who were trapped in the tragic explosion of May 9 in the Westray in Nova Scotia.

Shortly after that explosion, I wrote to the Governor General asking him to confer these medals of bravery. My request was supported by my colleague, the hon. member for Cape Breton—East Richmond, in whose constituency many of these draegermen reside.

Since that time under the leadership of Shirley Day Comish, the wife of one of the draegermen, and with the assistance of the Tim Horton stores across the province of Nova Scotia, a large number of petitions were collected calling upon the Governor General to confer these medals of bravery as quickly as possible.

I am pleased to present these petitions to the House of Commons today.

BILL C-268
