

and 14th years of Her Majesty's Reign, and intituled, "*An Act to confirm and give effect to certain rules and regulations made by the Judges of Her Majesty's Court of Error and Appeal in Upper Canada, and for other purposes relating to the powers of the Judges of the Courts of Law and Equity in that part of the Province, and the practice and decisions of certain of those Courts,*" shall continue to be exercised by such Judges, and shall extend to all matters and questions to arise and be decided under this Act.

CCXLIII. In citing this Act in any instrument, document or proceeding, it shall be sufficient to use the expression "The Common Law Procedure Act 1853." Short Title of this Act.

CCXLIV. And be it enacted, That from the time when this Act shall commence and take effect, the fourth, fifth, sixth, seventh, eighth, ninth, fourteenth and thirty-fifth Sections of an Act of the Parliament of Upper Canada, passed in the second year of the Reign of the late King George IV., intituled "*An Act to repeal part of and amend the laws now in force respecting the practice of His Majesty's Court of King's Bench in this Province,*" the forty-fourth Section of an Act of the Parliament of this Province, passed in the eighth year of Her Majesty's Reign, intituled, "*An Act for the relief of insolvent debtors in Upper Canada, and for other purposes therein mentioned,*" the whole of an Act of the Parliament of this Province passed in the eighth year of Her Majesty's Reign, intituled, "*An Act to allow the issuing of testatum Writs of Capias and respondendum in the several districts of Upper Canada, and for other purposes therein mentioned,*" the twenty-second, twenty-third, twenty-fourth, twenty-fifth, twenty-sixth, twenty-seventh, twenty-eighth, thirtieth, thirty-first, thirty-third, thirty-fourth, and thirty-sixth Sections of an Act of the Parliament of this Province, passed in the twelfth year of Her Majesty's Reign, intituled, "*An Act to make further provision for the administration of justice by the establishment of an additional Superior Court of Common Law, and also a Court of Error and Appeal in Upper Canada, and for other purposes,*" the first section of an Act of the Parliament of this Province, passed in the twelfth year of Her Majesty's Reign, intituled, "*An Act to amend and extend the provisions of the Act of this Province, intituled, 'An Act to allow the issuing of testatum writs of capias ad respondendum in the several districts of Upper Canada, and for other purposes therein mentioned'*" the whole of Act of the Parliament of this Province, passed in the Session held in the thirteenth and fourteenth years of Her Majesty's Reign, intituled, "*An Act to alter and amend the practice and proceedings in actions of Ejectment in Upper Canada,*" the whole of an Act of the Parliament of this Province, passed in the Session holden in the fourteenth and fifteenth years of Her Majesty's Reign, intituled, "*An Act to alter and settle the mode of proceeding in the action of Ejectment,*" the whole of an Act of the Parliament of this Province passed in Session held in the fourteenth and fifteenth years of Her Majesty's Reign, intituled, "*An Act to authorize and require the several Deputy Clerks of the Crown to perform the duties of Clerks of Assize in their respective Counties in Upper Canada, except as therein mentioned,*" the whole of an Act of the Parliament of this Province passed in the Session holden in the fourteenth and fifteenth years of Her Majesty's Reign, intituled, "*An Act to provide a remedy against absent Defendants,*" the whole of the Act of the Parliament of Upper Canada, passed in the second year of the Reign of the late King William IV., intituled, "*An Act to afford means for attaching the property of Absconding Debtors,*"—the whole of an Act of the Par-
