MAN AND HIS WORLD-STATEMENT BY PRIME MINISTER AS TO TERMS OF AGREEMENT

Right Hon. P. E. Trudeau (Prime Minister): In view of the question put to me earlier by the member for Sainte-Marie about Expo, I should like to inform the house that I have just received information which could be given to the house since it will be announced in Montreal very soon.

At a meeting held in Montreal yesterday and attended by representatives of Canada, of the province of Quebec and of the city of Montreal, the Minister of Industry, Trade and Commerce, on behalf of the government of Canada, accepted the proposal made a few days ago by the Finance Minister of Quebec, Mr. Dozois.

The three governments have agreed to an acceptable arrangement in order to pay the share of the city of Montreal in the deficit of Expo '67.

Under this agreement, Montreal will reimburse its share of the deficit over a period of eight years, as of April 1, 1969.

As for Quebec, an adjustment was made to the conditions for reimbursement previously negotiated. Reimbursement of the \$5.5 million payable during the fiscal year 1969-70 will be deferred until 1972. This arrangement will help Quebec to finance "Man and his World" in 1969. The press release indicates the numerada has supported "Man and his World" in municipality.
