**Mr. Brewin:** The hon. minister answered it by saying he would look into the matter further and report later. Is he ready to report to the house now?

Mr. Sharp: That was the first answer I gave. I gave a supplementary answer later.

# Inquiries of the Ministry CONSUMER AFFAIRS

ALLEGED MONOPOLISTIC ACTION OF OIL COMPANIES

Mr. W. M. Howe (Wellington-Grey): I have a question for the Minister of Consumer and Corporate Affairs. According to news reports this morning a statement has been made by an executive of the National Automotive Trade Association inferring that because of monopolistic action by the oil companies Canadians are paying too much for gasoline and auto parts. In view of this statement and its implications as far as the cost of living of every Canadian is concerned, would the minister institute an examination of this industry to insure that Canadians are being given fair treatment?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Of course, this is a matter which is constantly under surveillance by the Director of Investigation and Research under the Combines Investigation Act. I would also point out that I have not seen the statement to which the hon. member alludes, but the T.B.A. report is presently before the Economic Council of Canada for consideration, together with the report recently made in Alberta on the same subject. I expect to have a report from the Economic Council some time this spring.

Mr. Baldwin: Always we have surveillance but never action.

Mr. Howe: Mr. Speaker, might I ask the minister to make a statement some day in the house on these reports he is receiving, so all the people of Canada may understand what is going on.

Mr. Basford: If and when that is appropriate, Mr. Speaker, yes.
