CANADA SHIPPING ACT

AMENDMENT TO PROHIBIT LARGE OIL TANKERS PLYING CANADIAN WATERS UNLESS EQUIPPED WITH DOUBLE BOTTOMS

Mr. Benno Friesen (Surrey-White Rock) moved for leave to introduce Bill C-401, to amend the Canada Shipping Act (pollution).

He said: This bill anticipates sizeable future increases in tanker traffic in Canadian waters and recognizes the need to emphasize prevention of pollution in order to minimize the need for clean-up operations.

Motion agreed to, bill read the first time and ordered to be printed.

MEASURE TO IMPOSE DEATH SENTENCE IN ALL CASES OF MURDER AND TO RESTRICT POWER OF COMMUTATION

Mr. Donald W. Munro (Esquimalt-Saanich) moved for leave to introduce Bill C-402, to amend the criminal law (punishment of certain offences).

He said: The purpose of the bill is to impose the death sentence in all cases of murder, as that offence is defined in sections 212 and 213 of the Criminal Code, which means death caused in the commission of any violent crime such as bank robbery, kidnapping, hijacking or rape; to restrict the power of commutation of the death sentence to cases in which a majority of jurors are in favour of clemency, and to increase the penalties for certain narcotics offences and to lengthen the mandatory periods of imprisonment for both murder and the latter offences.

Motion agreed to, bill read the first time and ordered to be printed.

MEASURE TO LIMIT STATUTORY PREROGATIVE OF COMMUTATION OF DEATH SENTENCE

Mr. John Reynolds (Burnaby-Richmond-Delta) moved for leave to introduce Bill C-403, to amend the Criminal Code (death sentence).

He said: The purpose of this bill is to limit the governor in council's statutory prerogative of commutation and the Governor General's royal prerogative of pardon and reprieve to those cases where a jury has recommended clemency for a convicted murderer or been unable to agree on a recommendation.

Motion agreed to, bill read the first time and ordered to be printed.

Dubuc on behalf of the government and Mrs. Deborah Lawlor for a lease on the post office in Lyndhurst, Ontario began on January 3, 1973, what is the reason for the answer to Question No. 534 of the Second Session of the 29th Parliament contradicting this by stating that such negotiations actually began on November 14, 1972?
