ELECTORAL BOUNDARIES READJUSTMENT ACT

MEASURE TO CHANGE NAME OF CONSTITUENCY FROM BERTHIER-MASKINONGÉ TO BERTHIER-MASKINONGÉ-LANAUDIÈRE

Mr. Antonio Yanakis (Berthier-Maskinongé) moved for leave to introduce Bill C-599, to change the name of the electoral district of Berthier-Maskinongé.

Some hon. Members: Explain.

Mr. Yanakis: Mr. Speaker, as a result of the new division of the electoral map which came into effect for the election of May 22, 1979, part of the Lanaudière territory, which includes the municipalities of Lanoraie, Lavaltrie, Ste. Mélanie, Saint-Ambroise-de-Kildare, St. Marcelline de Kildare, Saint-Alphonse-de-Rodriguez, Ste. Béatrix and St. Côme, was linked up to the constituency of Berthier-Maskinongé. In order to identify better this area, Mr. Speaker, I should like to ask the House to allow me to change the name of the Berthier-Maskinongé riding, which will be known from now on as the Berthier-Maskinongé-Lanaudière riding.
