It is indeed a shocking state of affairs that a Government Department would be party to such an illegal act. It is odious and offensive, to say the least.

Canada produces the best butter in the world, and it is an affront to our dairy producers by those responsible, to have their product downgraded in this manner. The bad publicity engendered by this act will have repercussions on our export markets.

How does this action square with the Government's decree to buy Canadian in its efforts to stimulate our over-all economy? How does this action square with the Government's efforts to maintain employment in the agriculture section which is already hard pressed? Not very well, to say the least, Mr. Speaker. Therefore, I call upon the Government to take immediate action to reprimand those responsible, and to make sure that such an occurrence will never take place again.
