REQUEST THAT AFFIDAVITS BE TABLED

Miss Aideen Nicholson (Trinity): Mr. Speaker, just to clear up the situation, would the Minister table in the House all affidavits and papers filed with the Alberta court when the liquidator was appointed?

In view of the fact that the Minister said she was monitoring the bank over the summer to protect the Canadian taxpayer, will she tell us why, on August 29, even as the bank was being wound down, large advertisements appeared in Canada's papers offering a \$50 bonus to new customers who placed minimum term deposits with the bank?

Hon. Barbara McDougall (Minister of State (Finance)): Mr. Speaker, I think the Hon. Member asked two questions. As far as the affidavits and papers are concerned, I understand those are public documents and they would have been filed with the court.

As to the second part of the Hon. Member's question, the bank was in operation until September 1. Our role was to watch the bank to ensure that as long as it was viable it was functioning and that when it ceased to be viable we appointed a curator.

SALE OF CANNED TUNA—REQUEST FOR MINISTER'S RESIGNATION

Mr. Ray Skelly (Comox-Powell River): Mr. Speaker, my question is for the Minister of Fisheries and Oceans. I have the report in my hand from them dated May 3.

Mr. Speaker: Order, please. Is there a question?

Mr. Skelly: Will the Prime Minister indicate to the House on what basis the Minister of Fisheries released this material? How can the Prime Minister have any confidence in a Minister who would place rotten tuna on the shelves of Canadian supermarkets without having received a final recommendation?

Hon. John A. Fraser (Minister of Fisheries and Oceans): Mr. Speaker, the allegation which the Hon. Member makes was made earlier and I invited—

Mr. Skelly: Here is the report dated May 3.

Mr. Fraser: —the Hon. Member to bring me the documents upon which it is based. I have to say that I received a confidential report from the RPC on February 11. I received a further report from the independent committee which I struck as Minister on April 24. It was not until I received both reports and considered them carefully that the stock in question was released. If the Hon. Member has some information I do not have then I would be prepared to discuss the matter with him after Question Period.
