### HOUSING

On December 17, 1991 the government stated in a news release an increase in the budget pf \$6.1 million for 1992. However, on February 25, 1992 the co-operative housing program was cancelled altogether by the government. The co-operative housing program was highly successful in creating healthy, mixed income communities.

I join with my constituents in calling on Parliament to urge the government to immediately reinstate the federal co-operative housing program and to commit the \$6.1 million that it already committed previously and cancelled to the program which had been planned for 1992
