He would realize that this decision in no way contradicts our intention to sell the government's shares in the Canada Development Corporation, nor does it contradict the commitment made by the government during the last election campaign. If he read the press release, the hon. member would realize that Senator Austin, who is responsible for the CDC, indicated that, with the consent of Parliament, we would be establishing a new company, wholly owned by the Canadian government, in order to help the latter make the appropriate decisions, both in terms of selling its CDC shares and advising us on new investments.

### MANDATE OF PROPOSED NEW CORPORATION

Mr. Lorne Nystrom (Yorkton-Melville): Madam Speaker, I have not relied only on press reports; I have here some letters that were exchanged between Senator Austin and officials of the CDC. The Senator says in one place that the CDC has failed. In a second place he says that it has fulfilled its mandate. He talks about a new corporation, and he calls it a new corporation wholly owned by the Crown. Yet in another place he talks about a holding company. Can the minister, who is speaking on behalf of the Senator, tell us what the mandate of this new Crown corporation will be? What are its objectives? Why is the government creating a new corporation when the CDC was established for that purpose in the first place?

Hon. Charles Lapointe (Minister of State (Small Businesses and Tourism)): Madam Speaker, I am, perhaps, not as fluent in English as the hon. member, but I have also read the letters to which he is referring, and in those letters the senator states that, after ten years, the CDC has clearly fulfilled its mandate and achieved the objectives for which it was created, the first one being to enhance Canadian ownership of industries, which was fully attained. Furthermore, the CDC has become one of the major resource companies in Canada and, within the Canadian commercial sector, it is the Canadian company with the greatest impact in terms of risk capital and the purchase of high-technology companies.

#### MIRABEL-MUNICIPAL REPRESENTATIONS

**Hon. Jean-Luc Pepin** (Minister of Transport): Madam Speaker, the hon. member is asking me if I intend to be a good minister. The answer is pretty obvious; yes.
