A Brilliant Artist.
Mischa Elman, the brilliant young violinist, took his audience in the Grand Opera House by storm last night. His playing is marked by delicacy, precision and simplicity. When he draws his bow the first time, one realizes his marvelous certainty. During technical passages he is exquisitely sympathetic, and in his appearance and personality there is a girlish charm that captivates all.

The artist's programme last night was characterized by much beauty and variety. He played "Violin" and a sense of mastery only arrived at by the greatest toil and study. His emotional playing was shown in the "Andantino" of Martini-Krieger. Dash and charm, mingled with the beauty of tone in his marvelous rendering of Chopin's "Nocturne." His left hand seemed to compass everything on the keyboard with accuracy and clearness.

Wonderful is the delicacy which he brought to the "Serenade," the melody with which he imitates Schubert's "Serenade," and his harmonious double treble and pizzicato, in the "Pavane" of Liszt.

His intensity of emotion was further marked in the Beethoven sonata, and in the "Prize Song" from the Meisneringer, was a rare example of superb feeling and absolute grandeur of effort.

Other leading numbers in the evening programme were Liszt's "Symphonies," "Espagnole," and "Moussorgsky's" "Ballets." And yet the gifted young violinist graciously responded to three encores. The opportunity of hearing Mischa Elman is one of the rare privileges of this generation.

GARDEN COMPETITION
City Council Will Be Asked to Give \$200 for Prizes This Year.

The London Horticultural Society held a meeting last night, Prof. J. H. Bowman presiding. It was announced the Hon. Adam Beck has again contributed the sum of \$200 to be awarded in prizes for the annual garden and lawn competition in London, and the city council will be asked to give a similar amount.

It is the intention to hold a flower show in aid of the Byron Scholarship in August, and special seeds will be given the members of the society with the object of having them grow flowers for this exhibition. The seeds will be given free of charge.

Prof. Hutt, of the O. A. C. Guelph, will speak in the Normal School here on Friday evening next under the auspices of the society, and Mr. McCready, also of the Guelph College, and formerly of the local college, will deliver an address in the institute here on March 15.

STARVING AND NAKED
Cold Adds to Horrors of the Chinese Famine.

New York, March 1. Not only are the Chinese starving to death, as bitter as the winter in some of the provinces, according to letters which the Presbyterian Board of foreign missions received today from its missionaries in Hainan, but some of the worst cases of starvation are being reported from the provinces of Szechwan and Yunnan.

Many, many, are freezing to death daily.

NEW AGREEMENT IN TWO YEARS

Court House and Jail Agreement With City Expires On December 31, 1912.

WHAT ARE PROSPECTS?

It is said the City May Have to "pay Handsomely" When the County Drives a Fresh Bargain.

It was pointed out to The Advertiser today that the agreement between the city and county, whereby the city has the use of the court house and jail in the administration of justice, expires on Dec. 31, 1912, and the city will either have to have a court house and jail of its own or make a new agreement with the county.

A Committee Meeting.
The special committee of the county council appointed to deal with the matter of court house repairs, is called to meet on Friday, March 10, and plans, which have been prepared by City Architect Nutter and County Engineer Talbot will be examined and the cost to the city and county inquired into.

If an agreement is arrived at, the city will still find itself confronted by the problem of making a new bargain with the county for the use of the buildings within two years. The city representatives in the negotiation, who spoke to The Advertiser today, but some money will have to be contributed toward joint repairs in accordance with the agreement now in existence.

For Joint Building.
On the other hand, county representatives who are in favor of joint buildings take the stand that the city and county should get together, and stop spending money on the old buildings, which in the opinion of those who spoke to The Advertiser today, are in a state of disrepair, and the cost of repairing which means the throwing of good money after bad.

"I don't care to get mixed up in the matter," said one gentleman to The Advertiser today, "but I would like to point out that if the city agrees to spend a considerable amount of money on the present buildings now, the county will be in first-class shape to hold the city up when the time comes to make a new agreement with London. Why not look ahead a little, and seriously take up the matter of joint buildings, provided of course the city sells its city hall."

PARTED BY WAR BROTHERS MEET

THE MINERAL OUTPUT
An Increase of Over Six Millions in Ontario Last Year.

An increase of \$6,214,435 in Ontario's mineral output from 1910 is shown by a report issued by Mr. T. W. Gibson, deputy minister of mines. The total was \$39,232,814. The Cobalt and Sudbury districts were the chief producers.

The production of gold in the Province during 1910 was \$60,918, the largest amount since 1906. The only falling off was in the production of iron. The yield last year was 23,142 tons, compared with 26,777 tons for the previous year.
