to see whether the profits have been fair and reasonable. The amounts recovered from 600 contracts that have been renegotiated approximate \$300 million. We want to be sure that the contracts did provide only reasonable profit to the contractor. It is not possible in the early stages of a contract to establish costs that will protect against excess profits as the contracts go through.

Resolution reported, read the second time and concurred in. Mr. Howe thereupon moved for leave to introduce bill No. 173, respecting the Department of Reconstruction and Supply.

Motion agreed to and bill read the first time.

At eleven o'clock the house adjourned, without question put, pursuant to standing order.
