## AGRICULTURE

ASSISTANCE TO NORTHWESTERN QUEBEC FARMERS

On the orders of the day:

Mr. Réal Caouette (Villeneuve): Mr. Speaker, may I put a supplementary question to the Minister of Agriculture?

The Quebec Minister of Agriculture advises the farmers of the northwestern part of the province that his department is forwarding the amount required or appropriated for their crop failures in 1964 and he tells them at the same time that the federal government will pay them a similar amount.

The month of May is almost here and the farmers have not received anything. Is the minister aware of this situation and does he intend to satisfy the claims of the farmers in that part of the country?

Hon. J. J. Greene (Minister of Agriculture): Mr. Speaker, as the hon. gentleman knows, the federal government participated in a program of emergency agricultural relief in the province of Quebec to which I believe we contributed some \$12 million. The program is administered by the province of Quebec with a federal contribution. To the best of my knowledge the administration in Quebec has been a satisfactory one, although I have no knowledge whether all claims have yet been satisfied.
