Mr. D. V. Pugh (Okanagan Boundary): A supplementary question to the Minister of Finance. Will any such legislation on the tax bite be made retroactive to January 1?

WHEAT—INQUIRY AS TO EFFORTS TO PROMOTE EXPORTS

On the orders of the day:

Mr. Ed. Schreyer (Springfield): Because of the possible imminent retirement of the Minister of Trade and Commerce it becomes all the more important to ask this question now. In view of the fact that the wheat board's crop year has passed the halfway point, and in view of the fact that wheat exports are approximately 40 per cent of last year's level, can the minister say whether the government has in mind any special course of action to deal with this rather grave situation?

Hon. Robert Winters (Minister of Trade and Commerce): Yes, Mr. Speaker; an intensive program of hard selling.

Mr. Schreyer: As a supplementary question I would like to ask the minister whether in this intensive program of hard selling his department will examine the United States wheat selling program, under which they have been able to keep wheat exports running at approximately the same level as last year.

Mr. Winters: Yes, Mr. Speaker. I do not think we will be following the same practices, but we are in constant touch with the United States authorities in an effort to work cooperatively to maintain order in the wheat markets of the world, and we are making some progress.
