### DOMINION-PROVINCIAL CONFERENCE

### ESTABLISHMENT OF PERMANENT SECRETARIAT

Hon. Marcel Lambert (Edmonton West): Mr. Speaker, I wish to direct a question to the Prime Minister. On the agenda he tabled a few moments ago concerning the Federal-Provincial Conference next week there is an item called "mechanism of federal-provincial relations." Does this envisage discussions for the establishment of a permanent federal-provincial secretariat based in Ottawa?

Right Hon. P.-E. Trudeau (Prime Minister): Mr. Speaker, the general subject of the mechanism of federal-provincial relations is one of the subjects on the agenda.

Mr. Lambert (Edmonton West): That is obvious, Mr. Speaker, but I am asking whether the federal government would propose the establishment of a permanent federal-provincial secretariat based in Ottawa?

Mr. Trudeau: When I spoke of machinery, Mr. Speaker, I of course covered that subject;
