## LAKE LOUISE PROJECT—OPPORTUNITY FOR HOUSE TO DEBATE

Right Hon. J. G. Diefenbaker (Prince Albert): I have a supplementary question, Mr. Speaker. The answer given by the minister just now would indicate that finality has been brought about in this connection. On the basis of the objections that have been raised as a consequence of the various meetings held in this connection, does he not have some doubts now as to whether this project should be proceeded with? If he has not, will he assure the House that this House will have the opportunity of debating this project which, if it is carried out, means the end of the whole principle of national parks for Canadians?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, we had public hearings for the first time in the history of the national parks and thus all Canadians had the opportunity to express their views. I am appearing at present before the committee of the House which is considering the estimates of my department and if hon. members, including the right hon. member for Prince Albert, wish to ask questions, I would be glad to see them in that committee.

As for myself, I say again that no decision has been taken yet, because the government felt that it would be advisable to hold public hearings before doing anything.

## LAKE LOUISE PROJECT—BASIS FOR EXPENDITURE IN PROVIDING SEWER AND WATER SYSTEM

Mr. Doug Rowland (Selkirk): Mr. Speaker, may I direct a supplementary question to the Minister of Indian Affairs and Northern Development. As public hearings are still going on with respect to this project and since the minister indicated to the House that no decision has yet been taken, on what basis has the federal government spent over \$1 million in providing a sewer and water system—

Mr. J. H. Horner (Crowfoot): Mr. Speaker, may I direct a question to the Minister of Indian Affairs and Northern Development that has not been answered. Will a piece of legislation be put before the House which will detail the \$29 million or \$39 million to be spent in the national park in the area of Lake Louise?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, this Lake Louise project was submitted to the public several years ago. We invited people to make suggestions, and the only one received is that concerning the development now under discussion. We are considering the problem.
