2. Symposia expenses, (including simultaneous translation, travel expenses of panelists, speakers and CHS staff, rentals, hospitality, advertising) totalled \$112,000, of which \$5,000 was contributed by the Canadian Habitat Secretariat to York University for the organization of its symposium.

3. A report on each symposium is being prepared, translated and distributed to all participants. It is also being circulated to approximately 50 persons per symposium who were unable to attend but who requested all information relating to the topic, and to members of the Interdepartmental Task Force for Habitat, the IDTF Working Groups for Habitat, the Canadian National Committee for Habitat, and the Federal Provincial Preparatory Committee for Habitat. Approximately 300 people have requested copies of all 14 reports. In addition, a synthesis of the 14 reports is now being prepared.

HEALTH AND WELFARE—COST OF FIT-KIT

Question No. 4,950—**Mr. Jones:**

1. What was the total cost of the Fit-Kit recently introduced by the Minister of National Health and Welfare, including (a) salaries (b) binder (c) printing (d) recording (e) cost of cutting the records (f) other expenses?

2. Did the government copyright (a) all (b) part of the material in the Fit-Kit and, if so, at what cost?

3. What amounts were paid, or are payable to persons or firms for the publication and/or rights to publish the items contained in the Fit-Kit?

4. Who authorized the expenditures for the Fit-Kit and under what authority?

Hon. Marc Lalonde (Minister of National Health and Welfare): 1. (a) to (f) inclusive. The cost of 100,000 copies of the Fit-Kit was \$451,678. This figure includes the cost of printing, recording, cutting of the records and all other expenses, with the exception of the salaries of the Fitness Section. Staff salaries are estimated at \$15,000 over the last two years. Total amount recoverable to the Department from sales of these Fit-Kits will be \$80,000 for the balance of the 1975-76 fiscal year. Based on present sales trends, it is expected that this amount will be considerably greater in the 1976-77 fiscal year. It is anticipated that, ultimately, production costs will be fully recovered through Fit-Kit sales.

2. The government did copyright all parts of the material in the Fit-Kit. All material, except as noted below, was original work or contracted research of the department and, therefore, required no financial outlay for copyright.

3. *The Health and Fitness* booklet was originally copyrighted by the Scandia Insurance Company in Sweden and this has been produced in Canada and amended by permission of the copyright owners at no cost to the Canadian Government. The music on the Canadian Home Fitness Test was original music developed and purchased by the Canadian Government for \$14,087, which includes all future rights for use of this music. \$2,000 was paid in residuals for the four artists whose voices were used on the Canadian Home Fitness Test. Except for these, all other contributions from non-government sources have been assigned to the federal government at no cost.

4. The expenditures for the Fit-Kit were authorized by the Minister or his duly delegated representative under the terms of the Fitness and Amateur Sport Act.
