When a Member has given at least 24 hours written notice that he or she is unable to be present to move his or her motion under Private Members' Business on the date required by the order of precedence, and if that item of business is not one which has been designated "votable" by the Standing Committee on Private Members' Business, the Speaker, with the permission of the Members involved, may arrange for an exchange of positions in the order of precedence with a Member whose motion or Bill in the order of precedence has not been designated "votable";

That, in the event that the Speaker has been unable to arrange an exchange, the House shall continue with the business prior to Private Members' Hour pursuant to Standing Order 39(2), provided that there shall be no extension of the sitting pursuant to Standing Order 9(4), and any division on a debatable motion shall be deferred until 6 o'clock p.m. on the next sitting day.

For the purposes of this section, Standing Order 13(5) relating to deferred divisions on a Thursday shall apply; and

That this order shall expire Wednesday, April 15, 1987, at the ordinary hour of adjournment.

Mr. Speaker: Does the Hon. Parliamentary Secretary have the unanimous consent of the House to move the motion?

Some Hon. Members: Agreed.
