Apptd., 1875, a Commr. for the settlement of the Land Question, P.E.I. Served as Surgeon in the Turkish Army during the Crimean War, for which he holds the British and Turkish war medals. An unsuccessful candidate for Queen's in the Commons, Sept. 1873. Sat for Charlottetown in Leg. Assem., P.E.I., from 1873 to g.e. 1876. First returned to the Commons at last g.e. On an application for a recount the presiding Judge confirmed him in his seat. The Supreme Courts of P. E. I. and Canada subsequently reversed the judgment and awarded the seat to Mr. F. DeC. Brecken. On the resignation of Mr. Brecken, elected 20 Aug. 1884. A Liberal Conservative.—*Charlottetown, P.E.I.*

KAULBACH, Lieut. Col. CHARLES EDWIN. (*Lunenburg.*) 2ND MEM.

Of German descent. S. of Lieut. Col. J. H. Kaulbach, High Sheriff of Lunenburg, N.S., and grands. of Henry Kaulbach, Esq., who was High Sheriff of the same Co. for an extended period. Brother of Senator Kaulbach. B. at Lunenburg 13 July, 1834. Ed. there. Unmarried. Is a large ship and real estate owner. Was a Capt. and Adjutant in the Militia, and for a number of years in command of the Vol. Rifle Co. in Lunenburg. Is now Lieut. Col. commanding 75th Batt., Vol. Militia. Performed the duties of High Sheriff of the Co. for some years. Is Vice-Presdt. of the N. S. Soc. for the Prevention of Cruelty to Animals. First returned to Parl. at last g. e. 1878 and re-elected at last g.e., but in consequence of the irregularity of two of the Deputy Returning Officers, his opponent occupied the seat for one year, which, at the expiration of that time, the Court under Petition declared vacant, and a new election was held, Oct., 1883, when he was again returned.
