Mr. Millidge, moved for leave, to present a Bill to provide for the Support of the Grammer School in the Town of Halifax, which being seconded and put, and the House dividing thereupon, there appeared for the Motion 18, against it 12.

Against the Motion. For the motion. Mr. Campbell, Mr. Sargeant, Mr. Belcher, Mr. Wallace, Mr. Embrie, Mr. Collins, Mr. McMonagle, Mr. Skinner, Mr. Archibald; Mr. McElbinney, Mr. Rutherford, Mr. Schwartz, Mr. Baxter, Mr. Dimock, Mr. Pyke, Mr. James, Mr. Freeman, Mir. Moody, Mr. Dewolf. Mr. Tonge, Mr. Lusby, Mr. Dickfon; Mr. Hartshorne, Mr. Northup, Mr. Leonard; Mr. Howe, Mr. Bolman, Mr. Millidge; Mr. Maclean: Mr. Humpherys,

So it passed in the Affirmative.

The Bill was then presented, and read a first Time,

Resolved, That the said Bill be now read a second Time, and the same was read accordingly.

Resolved, That the Bill be committed to a Committee of the whole House.

Mr. Tonge, reported from the Committee appointed to wait on his Excellency the Lieutenant Governor with the Resolves of this House on the 21st and 27th June last, that they had waited on his Excellency accordingly, who was pleased to say, that he would give the necessary Directions to the Attorney and Solicitor General contained in those Resolutions, and that his Excellency had been pleased to appoint Jonathan Sterns Esquire, as Counsel to advise, and assist the Attorney and Solicitor General as aforesaid.

On Motion of Mr. Wallace, the House resolved itself into a Committee of the whole House, to take into Consideration the present state of the Government or School Lottery.

Mr. Speaker left the Chair, Mr. Skinner took the Chair, Mr. Speaker resumed the Chair,

The Chairman reported from the Committee, that they had gone through the Bufiness to them referred, and had come to a Resolution thereupon, which Report he read in his Place, and afterwards delivered it in, at the Clerk's Table, where it was read, and is as follows.

Refolved, That it is the Opinion of this Committee, that a Committee should be appointed for the purpose of preparing, and bringing in a Bill to repeal that part of the Lottery Act, which appropriates the Monies to be raised thereby, and to insert in the said Bill a Clause, for appropriating the said Monies to the Use of Roads and Bridges.

And the said Resolution being read a first and second Time, was upon the Question put thereupon, agreed to by the House.

Ordered, That Mr. Sterns, Mr. Wallace and Mr. Tonge, be a Committee, to prepare and bring in a Bill accordingly.

Mr. Secretary Bulkelsy, by Order of his Excellency the Lieutenant Governor, delivered to the House, an estimate of the Charge towards the Support of the Government of Nova-Scotia, and other Expences from the 1st Day of July 1794, to the 1st Day of July 1795, which was read,

Ordered, That the said Estimate do lie on the Table, to be perused by the Mem-

bers of the House.
