

On motion of Mr. *Scatcherd*, seconded by Mr. *Biggar*,

*Ordered*, That the Clerk of this House be directed to obtain from the Law Society of *Upper Canada*, a Return of all moneys received by said Society during the five years ending the first day of June, 1866; from whom received, and in what manner disposed of, with dates and items:

On motion of Mr. *Magill*, seconded by Mr. *Smith* (*Toronto East*),

*Resolved*, That this House will, on Monday next, resolve itself into a Committee, to consider certain proposed Resolutions, providing for the payment of Jurors attending Recorders' Courts in *Upper Canada*.

On motion of Mr. *Taschereau*, seconded by Mr. *Pope*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying His Excellency to cause to be laid before this House,—Copies of all correspondence between the Government and *Richard Pope*, Esquire, Agent at *St. François Beauce*, since the 19th July, 1865, together with copies of all Reports made by the said *R. Pope*, since that date.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

On motion of Mr. *McKellar*, seconded by Mr. *Mackenzie*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying His Excellency to cause to be laid before this House,—a Return of all Tenders received for the delivery of such Rations and Firewood as might be required for the use of the Volunteers on the Western Frontier, from the date on which they were first placed on duty in 1865; and also the names of parties (if any) who have delivered supplies without tenders being advertised for, and the prices at which rations and firewood were delivered at such station respectively, and the names of the Officers acting on behalf of the Government.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

On motion of Mr. *McMonies*, seconded by Mr. *Burwell*,

*Ordered*, That the Clerk of this House do prepare and lay before this House, a list of the names of all servants and employees of this House at the time of the removal from *Quebec*, and the number employed since and now in the service of the House, such Return to give the date when and by whom engaged, the salary paid, and the services performed.

On motion of Mr. *Huot*, seconded by Mr. *Taschereau*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying His Excellency to cause to be laid before this House,—copies of all papers, documents and evidence in the matter of the enquiry instituted as to the causes of the suspension of the *Caisse d'Economie de St. Roch*, and also of the report of the Commissioner who conducted the enquiry.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

On motion of the Honorable Mr. *Dorion* (*Hochelaga*), seconded by the Honorable Mr. *Holton*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying His Excellency to cause to be laid before this House—a copy of all correspondence and contracts, since the 1st May, 1864, relative to a change of proprietors of the *Beauport Lunatic Asylum*, and the support of the Lunatics in said Asylum.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.
