Winnipeg, April 27. - A despatch just received from Clarke's Crossing announces that Gen. Middleton made an advance to-day and expects to meet the rebels next day.

The death of Gabriel Dumont is still in doubt, but the loss of the rebels is now believed to have been serious.

A large party in scouring the ravine secured 18 dead mules and four more ponies, making thirty-two of the former and fourteen of the latter.

After the fight 150 rebels crossed the Saskatchewan two miles below the scene of the fight to the west side.

There are indications everywhere that the exit of the rebels from the ravine was a hasty one - in fact was a flight. For, trouble is expected but it is doubtful if any more serious engagements will be fought, as the rebels are said to be scattering.

Our success on Friday was greater than thought at first. Gen. Middleton and his staff now view the affair in the light of a pronounced victory.

The Sadder Ceremony of All.

CLARKE'S CROSSING, N.W.T., April 27. - Yesterday was a sad experience for our troops, as the remains of several brave boys were borne to their last resting places near the scene of the battle at Fish Creek. They were Private Hutchinson, of No. 1 Co., 90th regiment; Private Ferri, of No. 2 Co., 90th; and Gunner Demonty, of a battery, Quebec. Poor Arthur, died while the Toronto men were engaged in the battle, the obsequies of his companions were taken place at the scene of the battle.

Mr. D'Arcy Baker has since then been a melancholy spectacle and many a half-speech "too bad, poor fellow" could be heard as the report was announced "dead."

Two died. No clergyman was present with the force, so that the funeral services were read by the chaplain of the 90th.

No more fighting is expected before Tuesday, and even then there will be delay in getting the news, as information has to come by courier to this place, the distance to Battleford being about 40 miles, and largely through the enemy's country.

With Col. Otter's Column. BATTLEFORD, April 27. - Indians are seemingly almost as scarce as pinneeps. A few ugly-looking squaws with their papoose slung around, but they are as harmless as they are homely, except possibly for the information they carry to their tribes.

There is plenty of indication that the noble red man has been visiting these parts in the devastation caused, but the tribes have either taken a sudden dislike to the place or have appeased their appetites for rapine and plunder.

Sergt. Langtry, while out with a fatigue party, made a discovery to-day. He found at the back of some logs, a partially covered with straw, the corpse of a white man with his head terribly cut and his hands and feet bound.

On his return to camp the description he gave was found to tally with that of Payne, the Indian instructor, who was recently murdered by the Stoney's in a horribly treacherous manner.

Scouts are continually reconnoitering the country and bringing in reports. Detachments are to be sent to different reserves to bring the Indians to terms, and then nearly the whole force will probably march to the relief of Fort Pitt.

A detachment of mounted police escorted the teams to Fish Lake on Monday morning, and secured a large quantity of provisions. A large number of teams returned on the Swift Current trail, bringing on horse, which was about run out.

The Haligonians Overdressed. WINNIPEG, April 27. - The Halifax battalion will leave for Qu'Appelle to-morrow. It is understood they are to be hurried forward from Qu'Appelle to Gen. Middleton's headquarters at Battleford.

The officers have been invited at their own expense in repeating rifles and revolvers. A despatch from Fish Lake is not false. Private Blackwood is not seriously injured. Private Hilgop's arm has been amputated.

Private Hilgop has a bare chance of recovery. All the wounded are doing as well as can be expected.

Some of the troops under Major Gen. Strange, comprising scouts, mounted police, and part of the 65th, has reached Lone Pine, 80 miles north of Calgary. All quiet in that district.

The St. Paul and Manitoba railway company subscribed \$500 to the Winnipeg volunteer relief fund.

Rev. J. B. Siler has left here for the rest of his chaplain to the troops.

The Governor General's Body Guards are now in camp at Qu'Appelle. Twenty of them, together with 100 infantry, have been sent to intercept the rebels.

Up to 4 o'clock no tidings had been received of the whereabouts of the Saskatchewan force, which was down the Saskatchewan at Clarke's Crossing.

"I have every reason to be pleased with the York and Simcoe regiments, they are not only fairly efficient as regards drill, but they have a high moral tone, and are capable of every trying circumstance and have borne most cheerfully the great hardships to which they have been subjected during the journey round Lake Superior and subsequently in reaching this point.
