#### AGRICULTURE—QUEBEC—REQUEST FOR DAIRY POLICY

**Mr. Clément Vincent (Nicolet-Yamaska):** Mr. Speaker, on June 1 I put the following question to the Minister of Agriculture:

In order that dairy farmers, cheese factories and operators of manufacturing plants be well aware of the administrative details of the new dairy policy for the year 1965-66, could the Minister issue a clear and definite statement outlining these details as well as the approximate dates for the payment of adjustment and deficiency payments to producers?

Because of somewhat peculiar circumstances, the question has come up for debate only tonight. In the meantime, the Minister of Agriculture issued a release on June 2, giving certain explanations which we had been demanding since the end of March last on the new dairy policy which is in effect since May 1 of this year. In this press release, the minister admits that all dairy producers in Canada will not receive the minimum price requested by the opposition, by the producers and by all the various farm associations, namely \$3.50 per hundredweight.

At the present time the dairy producers throughout the country, and more specially in our province, are asking various questions. For some time they have been asked to be patient, but their patience is exhausted.

In the question I directed to the minister, I asked him to make as soon as possible the supplementary payments on milk shipped last year.

As everyone knows, the government seems to want to fix a national price of \$3.30. But to raise this price from 3.30 to \$3.50 per hundred pounds of milk, a payment is made for the milk shipped to processing plants during the year 1964-1965.
