Hon. Judy V. LaMarsh (Secretary of State): I have been given the following information by the Public Service Commission: As the Public Service Commission has no class "mailman" all answers to the questions below refer to the official class letter carrier.

1. Section 20 of the Public Service Employment Act reads as follows: "Employees appointed to serve in any department or other portion of the public service, or part thereof, shall be qualified in the knowledge and use of the English or French language or both, to the extent that the commission deems necessary in order that the functions of such department, portion or part can be performed adequately and effective service can be provided to the public."

2. (a) 161. (b) Four in the province of Ontario; none in other provinces.

3. Yes, provided a knowledge of the French language was indicated as a requirement for the position.

4. At the time of interview, applicants are given an oral examination to determine the degree of ability to understand or to speak the language, or languages, as the case may be. The Public Service Commission will shortly have tests designed to determine the candidate's ability to read and to write the language, or languages, as the case may be.

4. (a) Yes. Whereas the commission did not support exchanges with other countries, such projects will be supported in the future and will account for about 10 per cent of total programs. Furthermore, the following changes are made to domestic programs: Federal-Provincial: The name will be changed from "The Federal/Provincial Youth Travel Program" to "The Young Voyageur Program". Provinces will put more emphasis on the educational aspects of the program. Voluntary Agencies: Projects will be assessed on the basis of the contribution they make to the development of a higher standard of Canadian citizenship. A small international dimension is to be added. (b) No.
