## VICTORIÆ REGINÆ.

## CAP. I.

An Act for granting to Her Majesty certain sums required for defraying certain expenses of the Civil Government for the years one thousand eight hundred and forty-nine, and one thousand eight hundred and fifty.

[ 10th August, 1850.]

MOST GRACIOUS SOVEREIGN.

HEREAS by Messages from His Excellency The Right Honorable James, Preamble. EARL OF ELGIN AND KINCARDINE, Governor General of British North America Messages of 22 and and Captain General and Governor in Chief in and over this Province of Canada, 31 July, 1850, recited. bearing date respectively the twenty-second and thirty-first days of July in the present year one thousand eight hundred and fifty, and the estimates accompanying the same, it appears that the sums hereinafter mentioned are required to defray certain expenses of the Civil Government for the years one thousand eight hundred and forty-nine and one thousand eight hundred and fifty, not otherwise provided for by law: May it therefore please Your Majesty that it may be enacted, and be it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and of the Legislative Assembly of the Province of Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of the United Kingdom of Great Britain and Ireland, and intituled, An Act to re-unite the Provinces of Upper and Lower Canada, and for the Government of Canada, and it is hereby enacted by the authority of the same, That from and out of any unappropriated moneys forming part of the Consolidated Revenue Fund of this Province, there shall and may be paid and applied a sum not exceeding One Hundred and Seventy-three Thousand Four Hundred and Forty-eight Pounds Three Shillings and Ten Pence, Currency for the Civil Government to the Four Hundred and Forty-eight Pounds Three Shillings and Ten Pence, Currency, for for 1849 and 1850. defraying certain expenses of the Civil Government, for the years one thousand eight hundred and forty-nine and one thousand eight hundred and fifty, not otherwise provided for by law.

II. And be it enacted, That from and out of the unappropriated moneys, forming £2592 4s. 7d. appropart of the Jesuits' Estate Fund, there shall and may be paid and applied the sum of priated for educational Two Thousand Five Hundred and Ninety-two Pounds Four Shillings and Seven purposes in L. C. out of the Jesuita' Estate Pence Currency, towards the support of certain Educational Institutions in Lower Fund. Canada.

III. And be it enacted, That the due application of the moneys hereby appropriated Accounting clause. shall be accounted for to Her Majesty, Her Heirs and Successors through the Lords Commissioners of Her Majesty's Treasury for the time being, in such manner and form as Her Majesty, Her Heirs and Successors shall direct.

IV. And be it enacted, That a detailed account of the moneys expended under the authority of this Act, shall be laid before the Legislative Assembly of this Province, before the P. Parliaduring the first fifteen days of the Session of the Provincial Parliament next after such expenditure.
