It will be to be recollected, that the support of the English and Grammar Schools, independant of the College Establishment, has heretofore cost the Corporation £825 a year, besides contingencies.—And the great amount of Debts now due from the old Corporation has arisen from their Expenditure having necessarily, so much exceeded the amount of their income in keeping up the old Establishment.

On motion of Mr. Parker.—Ordered, that the House, do to-morrow, go into Committee of the whole, on a Bill for the Endowment of King's College at Fredericton, in the Province of New-Brunswick.

On motion of Mr. Crane.—The House went into Committee of the whole, on the Reports of the Auditor of Provincial accounts.

Mr. Taylor in the Chair of the Committee.

The Chairman from the Committee, reported, that they had gone into consideration of the matter referred to them, and submitted the following Report, which he read,

No. 14. Is the audit of H. Johnston, jun., and C. J. Peters' account for the expenditure of money, as Commissioners for the Marsh Road near the City of St. John, in 1827. This account appears by the Auditor's Report to be correct. And no commission is charged.

No. 13. Is the audit of J. W. Weldon's account for 1827, (Supervisor of the Great Road between Richibucto and Chediac River.) This account appears by the Auditor's Report to be correct, and no Commission is charged.

No. 11. Is the audit of Supervisor William Hannington's account for 1824, 1825, and 1826. This account appears by the Auditors Report to be correct, and a balance due to him of £65 : 19 : 3½, which balance is to be paid by the Supervisor, of the Great Road from Chediac to Richibucto, agreably to a Resolution of the House at the last Session. There is no Commission charged in this account.

Nos. 9 and 10. Is the audit of the Hon. W. Botsford's accounts for 1825 and 1826. These accounts appear by the Auditor's Report to be correct. Balance due the Province £58 : 13 : 2. It is proper to observe, with respect to the accounts of the Hon. Judge Botsford, that the whole amount of incidental charges in the expenditure of £1,368 : 19 : 9½, is only 17%, and no Commission is charged by him, a circumstance, in the opinion of your Committee, worthy of observance and imitation.

And the Chairman further reported that he was directed to ask leave to sit again.

Ordered, that the Report be accepted and leave granted.

The House adjourned until to-morrow morning, at 10 o'clock.
