QUESTIONS:

1. Question to be put upon each paragraph of a motion, 16.

2. Debate on a question adjourned, 78, 216, 253.—By adjournment of the House, 253.—By the Speaker leaving the Chair at 6 o'clock, 59, 142, 146, 162.

3. Amended, 103.—Superseded by amendment, 117.

4. Motions withdrawn, 59.—Decided to be out of order, 180.

5. Objection taken to a motion for an Address to Her Majesty, praying that a measure may be submitted to the Imperial Parliament, for uniting the Colonies of British N. America,—that it will result in new burthens upon the people, and ought therefore to originate in committee of the whole; Mr. Speaker over-rules the objection, on the ground that it will not involve any further action of the House after the passing of the motion, and therefore the provisions of Sec. 4, Cap. 14, Consol. Stat. of Canada, and of the 88th Rule of the House, concerning the mode of originating motions for any public aid or charge upon the people, do not apply thereto, 74.

6. A motion that a certain proposed Address be discussed from day to day immediately after Routine Proceedings, objected to, on the ground that a similar motion made the previous day is yet on the Orders of the Day, undisposed of; Mr. Speaker decides the motion is in order, 160.

7. Certain amendments proposed to a motion to postpone the debate on the said Address, to a particular time on the morrow, decided to be out of order; Decision appealed from, and confirmed, 180.

8. Previous Question moved (by the mover of the main motion), 180. Objection made, that it is not in order for the proposer of the original motion to move the previous question, which is in the nature of an amendment to his own motion; Mr. Speaker decides that the "Previous Question" is not an amendment, and the objection is therefore not valid; Previous Question carried in the affirmative, 191.

9. An Address to Her Majesty on the subject of a Confederation of the B. N. Am. Provinces having passed, and a motion being proposed for the appointment of a committee to draft such Address,—and an amendment being proposed for an Address to His Excellency to cause an appeal to be made to the people before the question is submitted to the Imperial Parliament; Objection is made that the amendment is not in order; Objection overruled by Mr. Speaker, 198.

10. Objection taken, at the third reading of a Private Bill which had been materially amended in committee of the whole, that it ought to be referred back to the Committee on Standing Orders, to report whether the amendments are in excess of the Notice; Mr. Speaker decides that it should be referred back, 240.

QUESTIONS NEGATIVED OR SUPERSEDED :

11. That the employment of the Volunteers called out for Frontier service, should cease at the earliest moment consistent with the term of their present engagement, 126.
